1. **Payment** in full must accompany this contract. Make all checks/money orders payable to *Happy Paws and Friends Pet Expo*. All cancellation requests must be made in writing. **Exhibitors canceling before September 1, 2008 will forfeit 50 percent of their Expo Space Rental Fee.**

NO REFUNDS will be made after October 2, 2008.

2. Booth assignments will be based on space requirements, products exhibited, date the signed contract is received, and consideration of the overall best interest of the show.
3. There will be no subletting of rented space.
4. Exhibitors will keep booth open and staffed during all hours of operation. **There will be a \$250 dismantling fee if any material is removed prior to the official end of the Pet Expo.** Set-up hours will be released on or before October 15, 2008.
5. Exhibitors shall be solely responsible, at their own expense, for installing and dismantling their own materials. Exhibitors shall repair any damage caused by dismantling and return the space to the condition it was received.
6. If, for any reason, an exhibit or its content is deemed objectionable, the exhibit, product or item is subject to removal.
7. *Happy Paws and Friends Pet Expo* will take reasonable precautions to safeguard Exhibitor's property by supplying an overnight security detail on Friday, November 21, 2008 and Saturday, November 22, 2008 to safeguard Exhibitors' property. However, *Happy Paws and Friends Pet Expo* will not be responsible for loss or damage to the property due to theft, fire, accident or any other cause beyond its control.
8. If *Happy Paws and Friends Pet Expo*, should be prevented from holding the Expo or if it cannot permit an Exhibitor to occupy his or her space due to circumstances beyond its control, including but not limited to strike, civil disobedience or an act of God, *Happy Paws and Friends Pet Expo* will have no other obligation to Exhibitor.
9. No food or beverage sales or samples are permitted without the written consent of *Happy Paws and Friends Pet Expo*.
10. The Exhibitor agrees to comply with local, city and state laws, regulations and ordinances for fire, safety, health and other matters. All exhibit equipment and materials will be reasonably located within the booth.
11. Exhibitors shall have and maintain general liability insurance during the time of the show as well as the move-in and move-out period.
